1. The remote e-voting period remained open from 9.00 A.M. IST on Thursday, the 17th day of December, 2020 up to 5.00 P.M. IST on Sunday, the 20th day of December, 2020.
2. The shareholders holding shares as on the “cut off” date, i.e. the 14th day of December, 2020 were entitled to vote on the proposed 5 (Five) resolutions as mentioned in the Notice dated the 10th day of November, 2020 of the AGM of the Company.
