2. The shareholders holding shares as on the “cut off” date, i.e. the 20th day of September, 2022 were entitled to vote on the proposed 2 (Two) resolutions as mentioned in the Notice of the AGM dated the 12th day of August, 2022.
3. The Company had also provided e-voting facility at the AGM to enable the shareholders attending the AGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
