Textual Information()	<p>The total paid up equity share capital of the company as on date comprises of 1,25,89,273 equity shares of Rs.10/- each and out of these 89,89,273 equity shares of the company are listed with the Metropolitan Stock Exchange of India. McNally Bharat Engineering Company Ltd. belonging to the Promoter group sold 61,000 equity shares of the company in accordance with SEBI circulars for offer for Sale through a separate trading window provided by the stock exchange on 24.05.18 and 25.05.18. Accordingly, the listed equity share capital of the promoter group was reduced from 68,01,724 equity shares of Rs. 10/- each representing 75.6649% of total equity of the company to 67,40,724 equity shares of Rs. 10/- each representing 74.9863% of total equity share capital of the company. On 14.08.2018 18,00,000 Compulsorily Convertible Preference Shares (CCPS) held by McNally Bharat Engineering Company Ltd. were converted into equal number equity shares and thereafter the total holding of that company became 10268698 number of equity shares.</p> <p>At the 75th Annual General Meeting of the company held on 25.09.2019 a special resolution was passed by the shareholders of the company whereby they consented to reclassification of EMC Limited from Promoter & Promoter Group category to Public category. This was subsequently approved by the Metropolitan Stock Exchange of India under Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 vide their letter dated November 28,2019. Thus 36,013 equity shares of Rs. 10/- each held by the erstwhile promoter now belongs to Public category .</p> <p>23,37,211 equity shares of the company held by the promoter McNally Bharat Engineering Company Ltd. were pledged with ICICI Bank Limited. On November 20,2020 ICICI Bank Limited acquired those shares from McNally Bharat Engineering Company Ltd. through pledge invocation.</p> <p>Presently the listed equity shareholding of Promoter & Promoter Group category stands at 4367500 representing 48.59% of total listed equity share capital of the company.</p> <p>The listed equity holding of McNally Bharat Engineering Company Ltd is 43,31,487 and the balance 36,00,000 equity shares held by them is not listed nor dematerialised.</p> <p>However, in accordance with instructions of the Metropolitan Stock Exchange of India communicated vide their e mail dated 23.09.2020 the details of only 89,89,273 equity shares of the company which are listed is being submitted.</p>
